What is SafePlus?

SafePlus is a health and safety improvement toolkit, developed with industry for New Zealand. It models what good health and safety looks like beyond minimum compliance and guides continuous improvement in capability and performance.

SafePlus features:

- review of current health and safety maturity in leadership, worker engagement, and risk management
- ten indicators describe capability in relation to good practice
- focus on work culture and how work is done, with input from people across your organisation
- reporting of strengths and development recommendations, with guidance for next steps.

SafePlus is optional to use. It supports collaboration, reflection, and learning, with the scope of assessments tailored to each user's priorities. It is not a standard or compliance audit.

Options for using SafePlus

Onsite Assessment and Advisory Service

Delivered by SafePlus-trained, HASANZ-registered, independent consultants.

Takes an in-depth view of how 3-4 critical risks are managed, to illustrate leadership, worker engagement and risk management capabilities, and how they shape health and safety performance.

Reporting gives a rich and detailed view of your organisation's health and safety capability, including recommendations, advice, and guidance, across the 10 SafePlus requirements and selected critical risks.

Download our survey questions, based on the SafePlus good-practice requirements, to use as a paper-based survey or in an online survey tool of your choice.

Make your SafePlus surveys anonymous to encourage participation.

The results calculator gives you a maturity rating and highlights areas to act on, including differences of opinion between senior leadership and other roles.

These resources are suitable for any size of organisation. They can be used on their own, or to test which risks to focus on in depth via a SafePlus onsite assessment.
