- The name of the manufacturer, and the size, type and number of pyrotechnic articles to be used;
- Details of positioning of firing points and mortar tubes and the methods of firing;
- The names and responsibilities of all authorised persons operating the display;
- An indication that the requirements of regulation 9.38 of the Health and Safety at Work (Hazardous Substances) Regulations 2017 will be met;
- Where indoor pyrotechnics are used, an indication that the requirements of regulation 9.43(4)(b) of the Health and Safety at Work (Hazardous Substances) Regulations 2017 will be met;
- In the case of aerial displays over 60 m in height, an indication that the requirements of regulation 9.39 of the Health and Safety at Work (Hazardous Substances) Regulations 2017 will be met.
